Tuesday, OCTOBER 23 or Wednesday, OCTOBER 24, 2012

Students must be able to collect artwork

At the beginning of the Spring Semester

NOMINATION PROCESS

Students must be nominated by a faculty member to participate. The attached form is for you to give **directly to the student**, who will turn it in to our D.E.P.S office. **The student must have the form with a faculty signature in order to participate in the exhibit.**

- Monetary Awards will be given to outstanding works as determined by a panel of judges comprised of professionals within the arts community of Chicago.
- D.E.P.S will select several of the exhibited works for purchase awards.

FACULTY RECOMMENDATION PROCESS/ ELIGIBILITY RULES:

- Participating artists must be **CURRENTLY ENROLLED UNDERGRADUATE STUDENTS.**
- Faculty nominations should include the student's specific art piece, series or project.
- Due to space limitations, all projects **MUST** fit within a space measuring **4' wide x 8' high by 4' deep**
- The nomination form should be filled out and given to the student directly. The student will submit the form to the Exhibition Coordinator/ C33 Gallery, First Floor, Chicago, IL 60605 **BEFORE FRIDAY, OCTOBER 12, 2012**
- Faculty may recommend as many outstanding works as they wish.
- Please make recommendations that reflect a standard of fully realized projects, not class exercises in basic techniques.
- DEPS reserve the right to edit the show based upon issues of safety, quality and space limitations.
